Corrective Action: Control weeds at the appropriate time, and no later than 11/1/2020. Per CSU extension, control of Russian knapweeds requires a multi-pronged treatment approach as a single control strategy will not likely be sufficient. Areas treated for Russian knapweed should be reseeded with desirable perennial grasses in the fall to compete with the treated knapweed.

Operator Comment: The areas with Russian Knapweed present within the reclamation area of the YF-2 production well location have been treated via mowing and spraying.
