#### COMMENTS:

The Bickler 24-34 (05-014-20647) was shut-in in November 2018. The well was originally scheduled to be abandoned in October 2020. Due to COVID precautions, all service rigs were shut down in April and May 2020, causing delays to the schedule and need to prioritize P&A work to wells with integrity concerns upon rig start-up. Although Bickler 24-34 was considered a high priority well, due to notification, scheduling and permitting requests per the local municipality, the move-in and rig-up was further delayed from October to December 2020. In coordination with the local municipality, Crestone is now scheduled to rig up on the Bickler 24-34 on 12/23/2020. The Bickler 23-34, Bickler 24-34 and Bickler 4-4-34 will follow for abandonment after the Bickler 4-6-34. Crestone is committed to abandoned all wells by 1/31/2021.
