The access road and location have not been reclaimed. There is an area at the location that has no vegetation growth that is approximately 120'x120' area. There maybe soil issues impacting vegetation growth. The access road does not have adequate vegetation and consists of predominately undesirable weeds (Kochia sp.). It does not appear that any reclamation work has been performed. The corrective action of the previous inspections has not been performed. Corrective action needs to be performed immediately to obtain compliance.
