Comment: It was observed in this inspection that the majority of the Location appears to be progressing towards COGCC 1004 revegetation standards; There are areas on the western half of the Location where weedy annual grass species such as cheat grass is the dominant vegetation; Cheat grass may be hindering desirable vegetative establishment and additional seeding and weed management may be needed to facilitate reclamation
