TEP Rock Mountain LLC (TEP) requests permission to tie the bradenhead into the separator downstream of the choke on the Federal PA 314-23 well. A diagram for plumbing the bradenhead into the separator is attached. The bradenhead pressure is currently ~270 psi. This will allow the bradenhead pressure to equalize with our separator/line pressure which is currently ~180 psi, and protect the integrity of the surface shoe.
