TA due to surface line issues. Plan to use as monitor well for pressure observation. Wells are used to monitor bottom hole pressure in the Weber formation to help manage our CO2 flood. The well is isolated with closed valves on the wellhead, disconnected flowline, isolation packer at 5762', and a tubing plug at 5836'.
