The purpose of this form 4 is for update purposes only. As previously stated on the follow up form 4 (doc id 402559445) from the high bradenhead pressure event during a frac, the bradenhead was tied into the production flowline after being initially managed via flowback equipment. The bradenhead is still currently tied into the production flowline and connected to the production separator and is approximately 100psi. Crestone will tie the production flowline at the separator into the fuel gas scrubber in order to to get the bradenhead pressure consistently under 50 psi. Crestone will provide another progress update by 02/08/21 via form 4.
