OPERATOR COMMENTS AND SUBMITTAL

Comments Distance from completed portion of the wellbore to nearest wellbore permitted or completed in the same formation was measured in 3D to the proposed Prairie LE 18-002HN.

Distance from the proposed wellbore to nearest existing or proposed wellbore belonging to another operator, including plugged wells, was measured in 3D to the Extraction PC 1S-66-2928 2CDH, API# 05-001-10040.

This well has a bottom hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 470' FNL and 397' FEL of Section 18. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

The Exception Location Waiver for Rule 318A.a. and 318A.c. is in the attached Surface Use Agreement on page 13 section 6.15 (B).

2	Drilling/Completion Operations	Drill stem tests (Rule 604.c.(2)L) Conventional drill stem tests will not be conducted on DJ Basin horizontal wells currently being executed or planned by Great Western. If plans change in the future a well specific drill stem testing plan will be prepared for that particular well. Note that GREAT WESTERN may elect to use one of several available wireline deployed tools for the purpose of measuring down hole formation pressures and/or collecting down hole fluid samples from the target formation(s) of a particular well.
3	Drilling/Completion Operations	Wellbore Collision Prevention – Rule 317.r Prior to drilling operations, Great Western will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed well. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log.
