Foundation is in the process of closing unused, unlined produced water pits at well locations in this area. The pits will be remediated to COGCC Table 910-1 standards as necessary. Foundation conducted on-site visits with the BLM representative in order to determine if landfarming could be approved as a remediation method on soils that exceed COGCC's Table 910-1 standard. Foundation is submitting this request to landfarm hydrocarbon-impacted soil at the above location in accordance with discussions at the on-site meetings. The landfarmed material will be bermed. Foundation anticipates landfarming activities to extend between 4 months and 1 year in order to obtain representative samples showing the landfarmed material has been remediated.
