All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs will state "Alternative Logging Program - No open-hole logs were run" and will clearly identify the type of log and the well (by API#) in which open-hole logs were run.
2	Drilling/Completion Operations	Closed loop system will be used. No pits will be built. Caerus will ensure 110 percent secondary containment for any potential volume of fluids that may be released.

Engineer	Offset Well Evaluation: Existing offset oil and gas wells within 1,500 feet of this wellbore meet standards. No mitigation required. Two active Wasatch G injection wells owned by Caerus, SGU *CP01B-27 M23 49 & SGU *8506B F26 496 are within the offset evaluation areas. These injection wells have been taken into consideration for the cement coverage COA#3. Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location.
