Engineer	Offset Well Evaluation: Existing offset oil and gas wells within 1,500 feet of this wellbore meet standards. No mitigation required. Two active Wasatch G injection wells owned by Caerus, SGU *CP01B-27 M23 49 & SGU *8506B F26 496 are within the offset evaluation areas. These injection wells have been taken into consideration for the cement coverage COA#3.  Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location.
