Renegade requests approval of alternative MIT for the UPRR-Habel #3-27 as allowed for by Rule 326.b(3) after Director consideration of any equivalent test or combination of tests.
Renegade believes the UPRR-Habel #3-27 demonstrates mechanical integrity due to a 9/6/2019 bradenhead test (Doc #402163148) performed showing no bradenhead pressure and tubing/casing pressure of 280/280 psi coupled with a 4/21/2020 bradenhead test (Doc #402377842) conducted showing no bradenhead pressure and tubing/casing pressure of 300/300 psi. The UPRR-Habel #3-27 was completed with a DV tool at 1042' and cemented with 120 sacks of lite cement. If the well lacked integrity old drilling mud would kill the well and casing pressure would not continue to build. Well pressures including the bradenhead will be monitored monthly to ensure integrity.
This well is SI as a result of the Third Creek Gas Gathering System shutdown on 6/1/2018 and was producing at the time of SI. The UPRR-Habel #3-27 was produced utilizing plunger lift equipment.
