#### COMMENTS:

Renegade requests approval of alternative MIT for the Thornburg #1-B as allowed for by Rule 326.b(3) after Director consideration of any equivalent test or combination of tests.  
Renegade believes the Thornburg #1-B demonstrates mechanical integrity due to a 12/16/2019 bradenhead test (Doc #402270989) performed showing no bradenhead pressure and tubing/casing pressure of 0/0 psi coupled with a 8/20/2020 bradenhead test (Doc #402473439) conducted showing no bradenhead pressure and tubing/casing pressure of 0/0 psi. The Thornburg #1-B was completed with a SS tool at 1364' and casing gelled with 1000 gallons. If the well lacked integrity old drilling mud would kill the well and prevent entry from this very low pressure formation. Well pressures including the bradenhead will be monitored monthly to ensure integrity. This well is SI as a result of the Third Creek Gas Gathering System shutdown on 6/1/2018 and was producing at the time of SI. The Thornburg #1-B was produced utilizing conventional rod pumping equipment.
