Comment:

FIR# 692401236 observed subsidence, remaining riser, debris and noxious weed issues on the Location. FIR required Operator to comply with 1004 Rules.

Limited visibility due to snow cover prevented Reclamation Specialist from conducting an accurate assessment of the reclamation, and determining if noxious weeds and debris issues have been addressed. It was observed in this inspection that the riser identified in the previous inspection has been removed. It was also observed that subsidence concerns remain evident at the base of the well marker.

This corrective action has not been addressed entirely and remains applicable. A followup inspection will be conducted to determine compliance with the remaining CAs and COGCC Rules

Perform Final Reclamation per COGCC 1004 Rules, including repairing subsidence, removing riser, controlling Noxious weeds and revegetating with desirable species.
