The facility is surrounded by agricultural fields to the north, south, and east and a vacant field to the west. The Mead irrigation ditch is located approximately 1,150' to the southeast. There are residential properties located approximately 750' to the west and 1,080' to the southwest. There is a Red-tailed hawk nest within 0.33 miles of the facility. Great Western will have completed facility closure activities before 2/15/2021. Groundwater well Permit# 88167 reported a static water level of 50' at the time of completion. There were no additional sensitive areas or wildlife habitats identified within a quarter mile of the facility. See the attached Figure 1 for an illustration of the location of the Site.

INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Great Western proposes to conduct closure of the Margil SE oil and gas facility. There are 7 wells associated with the Margil SE facility. The Margil 33-34D, 44-34D, 43-34D, and 34DD wells were P&Ad between 7/28 - 8/15/20. The associated flowlines were removed between 8/20 - 9/3/20. Partially buried vessel removal activities, tank battery closure activities, and flowline removal activities are planned for 1/26 - 2/5/21. P&A of the Margil 34-34D, 34PD, and 34TD wells is planned for 1/30 - 2/10/21. Great Western will conduct site investigation activities, field screening, and confirmation soil sampling activities during closure in accordance with COGCC 900 Series Rules. Discreet soil samples will be collected and analyzed pursuant to Rule 915, following the general sample collection guidance in Rule 915.e.(2). All waste generated during the closure activities will be managed and disposed of at Waste Connections' Denver Regional Landfill in Erie, CO in accordance with Rules 905 and 906.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Up to 27 discreet soil samples will be collected for field screening only and at least 18 discreet soil samples will be collected for laboratory analysis. Soil samples will be analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, and Total Volatile Petroleum Hydrocarbons (TVPH [C6-C10]) by EPA Method 8260 and Total Extractable Petroleum Hydrocarbons (TEPH [C10-C36]) by EPA Method 8015. Analytical results for TVPH and TEPH will be added together to calculate Total Petroleum Hydrocarbons (TPH). In addition, the soil sample from the base of the partially buried produced water vessel will be analyzed for the Soil Suitability for Reclamation parameters; Electrical Conductivity (EC), Sodium Absorption Ratio (SAR), and pH by Saturated Paste Method, and boron by Hot Water-Soluble Soil Extract Method. See the attached Figure 2 for an illustration of the Site layout and proposed discreet soil sample locations for field screening and for laboratory analysis.

Proposed Groundwater Sampling

Depth to groundwater in the vicinity of the facility has been determined to be approximately 50 feet below ground surface. Groundwater is not expected to be encountered during facility closure activities. However, if groundwater is encountered, Great Western will address sampling activities in a follow-up Form 27 Supplemental within 45 days after work is completed.
