INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the Norris D32-04F wellhead cut and cap and flowline removal. Approximately 560' of flowline will be removed. The COGCC will be updated in a supplemental form 27 if a portion of the flowline is abandoned in place due to field constraints. The wellhead will be cut and capped per COGCC rules. The form 44 Document number will be supplied at closure.

Proposed Soil Sampling

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
