The original well completion report submitted in 1990 did not include any of the Niobrara and Ft Hays completion information. The WBD also submitted in 1990 happens to show the the Ft Hays perms, but yet still left out the Nio info. This well should have been reporting as Niobrara/FtHays/Codell producing since 6/27/1990. The Codell is later re-frac'd in 2003, and the Niobrara is re-frac'd 2008. Documentation of this wells completion history is included in these attachments.
