Previous inspections documented that the shut off valve is adjacent to P&A Marker services nearby Well. Inspections also observed concrete pad/debris remaining on the Location. Inspections required Operator to remove debris by 11/1/2019.

It was observed in this inspection that concrete remains evident in the area of the well. Corrective action does not appear to have been addressed, and remains applicable.

Corrective Action:

CA from Inspection #692401238: Remove debris & remnants of concrete Pad from Location; reclaiming/re-seeding disturbed areas as necessary.
