Production equipment is still on site.
The most recent valid mechanical integrity test (MIT) was conducted on 1/28/2020.
This wellbore was temporarily abandoned because operations were suspended after completing two stages and stacking out with wireline due to parted casing.
HighPoint has plans to discuss investigating the casing issue and potentially resume completions.
This well is isolated by shutting in two master valves at surface.
