COMMENTS:

The sundry approved 8/14/2020 for a bradenhead gas combustion strategy (DOC#: 402463943) stated an approximate start date of 9/30/2020. The bradenhead gas combustion device successfully brought the bradenhead pressure below 50psi. At the end of the six month approved period the bradenhead combustion device (MESSCO Unit) was disconnected from the bradenhead and the bradenhead was shut-in so a bradenhead test (Form 17) could be conducted. The bradenhead test dated 1/27/2021 showed that after disconnecting the combustion device the bradenhead built to 63 psi. Flow rate data was collected during the mitigation process and showed a flowrate of 0.14 MSCF/D.

To comply with the operator guidance Extraction requests to continue routing the bradenhead gas to a catadyne heater within 20' of the wellhead to maintain bradenhead pressure below the 50psi threshold.
