**COMMENTS:**

In accordance with the previously submitted mitigation plans, the bradenhead was tied into the flowline via a kelly hose tin-in on 09/29/2020. Crestone made various adjustments and the bradenhead tie-in resulted in lower bradenhead pressure (~104 psig). Crestone plans to continue consultation with the COGCC engineering staff to modify the mitigation in order to bring the pressure under 50 psig. A follow up form 4 will be submitted when the modified mitigation plan has been implemented.
