INITIAL ACTION SUMMARY

Bonanza Creek Energy plugged and abandoned the Monahan Federal #24 wellhead on 12/18/2020. As a direct result of the P&A activity, the associated production facility is being decommissioned. There is one (1) concrete water vault on location that was removed on 1/4/2021. There was no visual or olfactory evidence of impact to the surrounding soils. One grab type soil sample was collected from the bottom of the open excavation and submitted for laboratory analysis. PID readings were collected from each sidewall.
