I, Inspector Mike Longworth, conducted an inspection at TEP ROCKY MOUNTAIN LLC, UNOCAL-66S96W 35SWSW, Location ID: 334773 in Garfield County, Colorado. Location is in close proximity of Parachute creek and in a High Priority Habitat Area. (Mule Deer Winter Concentration Area, Elk Winter Concentration Area)

During this inspection the following possible compliance issues were observed:

Well signs are illegible, weathered, and balckening.

No capacity on tank or label.

unmarked deadman.

Unused polylines near wells.

Access road shows signs of lack of stabilization BMP's in some areas (rutting is present). No tracking bmps observed for access road.

Storm water bmps are failing at access right away and CR215. Storm water is moving across CR215 and washing away the shoulder on opposite side of road.A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
