 On Wednesday 2/10/21 at approximately 13:30 hours, I, Inspector Corey De Paolo, Conducted, a domestic tap inspection at TEP ROCKY MOUNTAIN LLC Domestic Tap /1NWNW, Location #456904 in Garfield County Colorado.
 While there, I observed normal production operations.
 The domestic tap is derived from the W-37-1 separator sales line. See photo #2879. The W-37-1 sales line is separate from location #335032 sale line. See photo # 2880. The W-37-1 sales line follows the access road to the base of the hill where the domestic tap stubs out of the ground. See photo #2881. The pressure is regulated by a Big Joe pressure regulator. Downstream of the regulator is a knock out bottle see photo #2882. After the knock bottle the domestic tap splits in to multiple taps. See photo #2883. One domestic tap services the house directly to the West of where the domestic tap stubs out of the ground.
