Comment

Inspection #696201605 documented noxious weeks (Musk thistle, Common Mullien) establishing on the interim areas on and required Operator to comply with Rule 1003.f.

Operator submitted FIRR #402481219 stating "All noxious weeds on the partial reclaim at 35-BV have been chopped out, bagged and discarded".

Limited visibility due to snow cover prevented Reclamation Specialist from conducting an accurate assessment of the reclamation area. FIRR states weeds were bagged and discarded, however remnant Musk thistle plants from last year's growing season was observed on southern interim areas; Unclear if corrective action has been addressed.
