Soil will be periodically tilled. Field screening will be performed to determine current condition of the soil. If contamination is still present, soil will be removed and disposed of it at the Central Waste Site for the lease.

Based on analytical results of soil samples collected 9/26/2018, additional remediation work is necessary at the release point and associated release area. Additional tilling activities will occur in 2020 and 2021 to continue remediation of impacted area. Soil samples will be collected August 2021 to review remediation progress. Per BLM COAs, not dirt is allowed between March 1st - June 30th.
