The Form 2 approvals for wells at this location contain two COA for mitigation of proximate non-operated wells. The initial development plan for this location is to drill and test a single well, and then to drill the remaining wells based off the test data.

GMT proposes to run a bond long on the producing Normand Estate 10-7 (05-039-06477) and to mitigate the two Option 3 wells which will be affected by the Vulcan 6-64 10-8 1HN (API: 05-039-06686), and to address the other COA'd wells once drilling plans pursuant to the results of the productivity test on the Vulcan 6-64 10-8 1HN are in place.

The DA Status wells requiring option 3 mitigation affected by the Vulcan 6-64 10-8 1HN are the Lycus 4-13 (API: 05-039-06396) and Normand Estate 10-4 (API: 05-039-06478).

The DA Status Nordman Estate 9-16 (05-039-06453) will not be affected by the drilling of the Vulcan 6-64 10-8 1HN and would be mitigated prior to drilling any other well on the pad, along with the Coggins Et Al 1-10 (API:05-039-06383), Running Creek State 1 (API: 05-039-06443), and Running Creek 15-3 (API:05-039-06480).
