#### COMMENTS:

Investment Equipment respectfully requests permission to combust the excess natural gas produced by this well. Investment Equipment operates the Davis W T 1, an oil well that also has de minimis natural gas production. Estimated volume of gas to be combusted is approximately 1 MCF per day with 98% efficiency. With such low gas rates, it is not economic to construct the infrastructure required to connect the well to a gas sales pipeline. This location is currently APEN-exempt, as per the attached letter.

Gas analysis is attached.

Due to the de minimis gas rates produced by the well, there are currently no plans to construct infrastructure to tie the well into a gas sales pipeline. The nearest infrastructure is approximately 8.5 miles away.

Gas is utilized onsite as much as possible but it is such a low volume that it often must be supplemented with propane.
