-Conduct soil sampling to determine the likely cause of poor revegetation. As described below, results shall be submitted with a remediation/reclamation plan for the project area.

-Submit a plan to remediate and reclaim the project area. Plan needs to include at a minimum, the following:

- Copies of any soil testing results from testing that was previously conducted at the location.
- Soil sample results from 2020 soil sampling, and a map showing sampling locations.
- A detailed soil remediation and reclamation plan based on soil sampling results.
- Schedule to conduct soil remediation activities and reclamation activities in coordination with surface owner and crop timing at all phases of remediation/reclamation.

Operator Comment: HighPoint Resources' reclamation consultant performed periodic monitoring of this location in June, 2020, and a report of their findings is included with this response. The consultant collected soil samples from both the project area and an adjacent undisturbed area, and the results are provided in the included report. Results from soil samples taken previously at this location are also included. Based on their observations and the results for the soil samples, the consultant is recommending reseeding the bare areas in spring 2021 and preceding the reseeding with the application of Nitrogen, Sulfur and Phosphate in the fall 2020. Prior to reseeding, additional soil samples will be collected to assess the effectiveness of the amendments. All treatments and other future work will be coordinated with and approved by the landowner and/or tenant farmer. Weeds on the location were sprayed by Premier Weed Management on June 13, 2020 (see attached invoice with detail of application). Regular monitoring of reclamation success will continue until such time the reclaimed area meets the 1004 reclamation standards.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Operator submitted materials are reviewed. Operator needs to implement, monitor, and manage reclamation on the location until reclamation standards are met in a way that is informed by soil data.
