##### Proposed Procedure:

1. MIRU. Pull 2 3/8" tubing.
2. TIH w/ RBP & set @ 6802'. Dump bail sand & load well. Test casing to verify integrity.
3. ND WH. Spear 4 1/2" production casing to remove out of slips.
4. TIH w/ 1 1/4" 3.02# CS Hydril stick pipe to 1375' in production casing annular space. Mix and pump 100 sxs cmt from 1375' to 1175'. Pull 1 1/4" tubing.
5. Set slips and NU WH.
6. Wait on cement to cure at least 4 hrs. RU wireline & run CBL to verify cement placement.
7. Perform bradenhead test to verify psi blows down to 0 w/ no water flow.
8. TIH w/ tubing w/ retrieving head for RBP. Retrieve & TOOH.
9. TIH & land tubing. RDMO WO rig. Return well to production.
