It was observed in this inspection that this Location does not meet COGCC 1004 Final Reclamation requirements; Anchors equipment remaining; Access road has not been recontoured/reggraded and reclaimed.

Well PA 6/11/1996; Pursuant to Rule 1004.a, surface equipment required to be removed by 9/11/1996, and all reclamation work required to be completed by 6/11/1997. Due to the significant nature, extent, or duration of this alleged rule violation, and due to reclamation compliance issues with other Locations in the area, no corrective action date will not be applied and Location will remain out of compliance until final reclamation work has been completed pursuant to COGCC 1004 Rules.
