Operator Comment: Product observed at surface is associated with Spill/Release ID 478014, not a second subsurface release. A new spill/release at the same location has not occurred, as such will not be reported. Well and flowline associated with Spill/Release ID 478014 have been shut-in since initial release occurred. As noted in the inspection document, excavation activities have not been performed to remove released product from Spill/Release ID 478014. Until excavation activities are able to commence, there will be potential for additional product from Spill/Release ID 478014 to daylight; however, if this does occur, it will not be defined as an additional subsurface release.
