Comment:

The access road has not been reclaimed. It appears topsoil has recently been spread along the access road and in areas of the location. The access road and areas of the location will need to be reclaimed. Soils should be decompacted and stabilized. The vegetation grew really well where straw blanket was installed at the location. The plastic netting from the blanket is bunched up in areas and should be cut and removed where possible without pulling up the vegetation. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.
