Comment: It was observed in this inspection that BMPs are missing or insufficient to stabilize pad during wet conditions, and to mitigate off location sediment transport. Stormwater control ditch on the west and southern perimeter of the pad currently discharges directly from pad onto the adjacent interim areas/lands; BMP has not been constructed with an outlet to allow for sediment laden-free stormwater discharge in accordance with good engineering practices.

Corrective Action: Comply with Rule 1002.f and implement required stormwater and erosion control measures. Ensure BMPs are adequate for the site's conditions, are installed in accordance with good engineering practices and maintained in proper functioning condition.
