The horizontal portion of the wellbore will be logged with a measured-while-drilling log with gamma-ray. The Form 5, Completion Report, for this well will list all logs run and have those logs attached. The Form 5 shall state "Open-hole logging exception - No open-hole logs were run", and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
