**COMMENTS:**

This Sundry is being submitted to address a historic incident that is being identified as an "unresolved spill/release" in COGCC's COGIS database. The incident is being associated with Location ID 335162 which is an active Grizzly Operating location and Facility ID 291038 which is a producing well on the referenced location. The incident is being identified as an "unresolved spill /release" associated with the former operator Highpoint Operating Corporation (formerly known as Bill Barrett Corporation) and their assigned Operator Number 10071. This incident occurred on September 18, 2010 and the Form 19 can be referenced under COGCC Document Number 2521443.

Grizzly Operating was able to locate historical documentation which indicates that Bill Barrett Corporation did previously submit documentation requesting closure of this incident. This incident pre-dates the current eForm system and all documents were sent via email to the assigned Environmental Protection Specialist for review and processing during this time. Grizzly Operating has attached the referenced historical documentation to this submittal and is formally requesting that the incident being identified in the COGIS database as an "unresolved spill/release" be closed and given a No further Action determination by the COGCC.
