 On 2-26-2021, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor/Noise. The complainant Kurt Janz 9020twin sisters Cir Erie CO stated the issues were occurring outside of complainants home.  
 On 3-2-2021, I attempted to make contact with the complainant who indicated that on 2-26-2021 experiencing jet engine like noise and chemical smell.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual odors or noise in or around location. The equipment on site is Halliburton's Tier 4 Quiet fleet performing fracing phase. Third party sound data has been attached to inspection Doc# 693504616.  
 At time of inspection, I spoke with on-site fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place.
