COMMENTS:

Surface wellbore was drilled per approved and planned operations. Surface casing was run and during cementing operations cement was unable to be circulated as per the approved plan. Surface casing is now full of cement, and estimated TOC in the wellbore-casing annulus is at ~1,765 ft MD/TVD. Current plan forward is to clean out cement from inside surface casing to casing float collar (located at ~2,228 ft MD/TVD) and run a CBL/Temperature Log to determine TOC. After determining TOC, perforations will be placed in the 9-5/8" surface casing and circulation will be established back to surface. Remedial cementing operations will then commence, placing cement in the wellbore-casing annulus back to surface as planned.
