#### COMMENTS:

Wexpro Company requests to install (1) 48" HV Cimarron combustor (dimensions 48" wide by 25' tall) and a 50-100 gallon knock out tank at the above mentioned well location. The combustor must be installed prior to May 1, 2021 due to CDPHE and COGCC regulations. The installation of the combustor will be on the existing well location and will not require any new surface disturbance. The equipment will be painted shale green to match the existing approved paint color. Upon installation completion, an updated site facility diagram will be submitted to the BLM Craig Field Office. The existing well location is not within an NSO area and CPW consultation was not required.
