On 3/1/2021 COGCC Staff, Kris Neidel inspected the Dry Creek UT HD 31 #1A, API #107-06175. Weather was clear and 25 degrees. It appeared that the location had not been plowed all winter. None of the pad surface was observable due to snow coverage. Inspector walked from county road. The well was TA at the time of inspection. It appeared a pump string is in the well, No pumping unit was on the well, or observed on the location. The shed on location that contains water well (permit #66138-F) was fenced in with cyclone fencing. Well head of 107-06175, surface flowline and tank battery were all fenced with cyclone fencing. The sign at the wellhead is not compliant with rule 605.d. Signage at tank battery is not compliant with 605.e. See attached photos and Corrective Actions.
