This form has been prepared to support removal of the plugging and abandonment of the subject well. In accordance with COGCC Rule 911 and Rule 915, an initial representative soil sample(s) will be collected in/around the wellhead area. Initial laboratory soil analysis will include only BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, naphthalene, TPH, pH, EC, SAR and boron. Groundwater, if present, will also be collected and analyzed. Identified impacts will be reported as required and a Form 19 will be submitted, and remedial investigation will be conducted as appropriate.

In accordance with COGCC Rule 911 and Rule 915 soil sample(s) will be collected during closure of the area around the subject well and the area around the pumpjack. The pumpjack sample will be field screened; if necessary, the pumpjack sample will be sent for laboratory analysis. The wellhead sample will be analytical as described in the Initial Action Summary. Initial laboratory analysis will include only BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, naphthalene, TPH, pH, EC, SAR and boron. If impacts are confirmed, the full Table 915-1 list of analytes will be tested for and additional excavation effort may be conducted to delineate horizontal and vertical extents.
