Access road and location show signs of lack of stabilization BMP's in some areas (rutting is present). Culvert on main access road needs maintained (39.52242 108.13237). Main access road ditch has tire ruts and needs maintained.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
