Comment: The access road and location have not been recontoured and reclaimed per 1004 Rules. The access road is swaled and areas of the location do not match the surrounding contours. There is an area 150'x100' at the location with no vegetation growth. It appears soil issues are preventing vegetation establishment. A soil analysis needs be performed to evaluate soil conditions to reclaim soil issues. The access road and location will need to be recontoured and reclaimed to establish a uniform vegetation cover.
