Anonymous complaint 200449051 received 06/25/2020 alleging dumping of E&P wastes in field to north of Kauffman field offices at 8979 Weld County Road 22, Fort Lupton, CO 80621 (listed as Weld County Parcel 131109400071) COGCC non-facility 477263 and COGCC location 477261 created for documentation of investigation as no Kauffman operated oil and gas facility related to E&P waste disposal exists at the site. Complainant alleged that they believed soils brought to site contained hydrocarbons based on olfactory observations (odor) at a distance.

Spill/Release reported by operator following preliminary site investigation by COGCC staff and operator staff.

Site investigation and remediation project 15951 ongoing at site.

Operator representative on location at time of inspection as were contractor crew installing monitoring wells as proposed in site investigation and remediation plan (15951 - docs 402486065 and 402561887)

Inspection was in response to 48 hour notice of activities at location provided to staff by Operator representative Jeff Rickard.

walked across spreadfield from east to west and then diagonally for NW to East middle. Soils at surface are sandy in many areas with some clayey sand in other places. Soils at surface appear to be in place but have been disturbed by removal of impacted soils. Operator representative was on site collecting soil samples for laboratory analysis at time of inspection. Photos attached show general conditions of spreadfield. Observed soils with grass roots in several places which may indicate impacted soils brought to site have been removed. Confirmation by sampling and analysis still needed to document.
