The domestic tap is derived from the sales line of the MAHAFFEY-66S95W /36NWSW location #334597. See photo #3111. The pressure is regulated with a Big Joe regulator. See photo #3112. The pressure is then regulated again by an in line little Joe regulator. See photo #3112. Downstream of the regulators is a fluid knock out. See photo #3113. All fittings appear to be adequate to handle the maximum operating pressure of the regulators.
