COMMENTS:

HPR is requesting to continue the originally prescribed blowdown mitigation for an additional 6 months given progress was observed during the first 6 months and the annulus does not appear to be charging up as quickly or to as high of a pressure. Details of the first blowdown period are attached on the mitigation spreadsheet. As was discussed with state engineering staff over the phone, HPR has recently begun to experience liquid discharge from this well's Bradenhead. Liquid samples have been collected (analysis withstanding due to laboratory turn-around time) to compliment the gas samples previously collected. Our conclusion of gas composition based on samples previously submitted, along with other COAs are also noted on the attached mitigation spreadsheet. A form 17 Bradenhead test has been completed after a 7 day shut in period, this has been submitted to demonstrate where the true Bradenhead pressure stands relative to the action threshold. HPR will continue to maintain pressure records for an additional re-evaluation of the stabilized Bradenhead pressures at the end of this second mitigation period. We will update the state on our progress by submitting a follow-up Form 17 and Form 4 at the end of this period.
