Scott and Brian,

Based on review of data presented from samples collected 4/20/2011 for the above-referenced release , it appears that no further action is necessary at this time. Trace hydrocarbon detections identified at four of the sampling locations are below Table 910-1 levels. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards, or if ground water is found to be significantly impacted, then further investigation and or remediation activities may be required at the site.
