COMMENTS:

Bradenhead pressure was found to be equal to or greater than 50 psi and some liquids were present. Samples have been collected (gas and liquids) for analysis to aid in determining origin of gas. HPOC is blowing down the Bradenhead daily for a 3-6 month period and will maintain pressure records for a re-evaluation of the stabilized Bradenhead pressures at that time. We will update the state on our progress by submitting a follow-up Form 17 and Form 4 at the end of this period.

Operator will implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare.</p> <p>2. Prior to starting bradenhead mitigation, if a sample has not been collected within the last twelve months collect bradenhead and production gas samples for laboratory analysis. Sampling will comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results will be provided to the COGCC within three months of collecting the samples.</p> <p>3. Operator will implement measures to get an initial estimate of the gas flow rate and/or volume from the bradenhead. During the shut-in period record pressure data to adequately characterize the build-up. This mitigation plan may be used for six consecutive months from the date test reported on the Form 17.</p> <p>4. At the conclusion of the six months (9/11/21), conduct a new bradenhead test and submit the Form 17 within ten days of the test and submit a Form 4 Sundry that summarizes current well condition. The sundry should include details of the future plans, sample analysis interpretation, and the flow rate information and pressure data.</p> <p>Shut in bradenhead pressure shall not exceed 50 psig.</p>
