On Wednesday 3/17/2021 at approximately 1000, I, Inspector Scott Ramsey, conducted a routine inspection at TEP RU 31-12V, at Location # 323866 in Garfield county Colorado.
While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, Black bear, NSO Habitat and Wildlife Management Area. This location is also within the 317B buffer.
During this inspection the following possible compliance issues were observed:
1. Tank battery signage does not meet requirements of new rule 605.e
2. No evidence of tracking control BMP's
3. Location show signs of lack of stabilization/compaction and slight tracking off of location
Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
