Comment: The fence at beginning of the access road has not been installed back to the original position. It appears the reclamation and seeding was unsuccessful. There is insufficient desirable vegetation establishment and the location consists mostly of undesirable weed vegetative debris. The undesirable weeds need to be controlled and additional seeding will need to be performed to re-establish perennial vegetation cover. An extended corrective action date is provided to assess the location and to perform additional reclamation.
